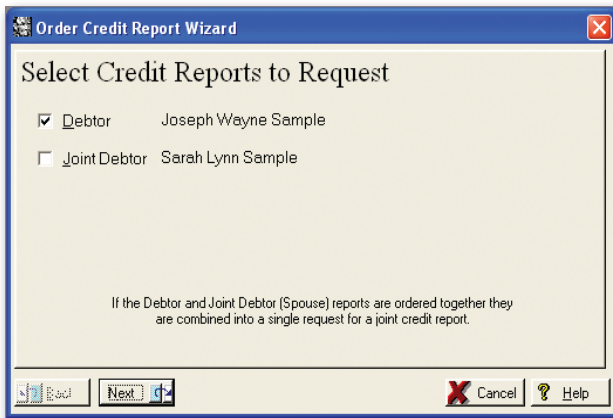

# Order and import credit reports into Best Case

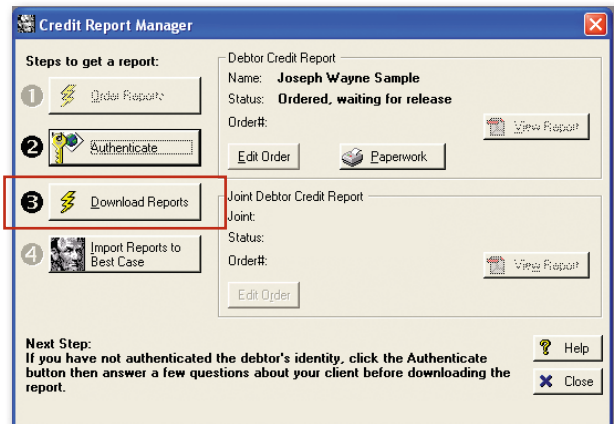
After setting up an account with a credit report provider, you are ready to start downloading credit reports into Best Case. Open a client file, navigate to the Tools Menu in the top menu bar, then click Credit Report.

## 1 Order a single or joint credit report



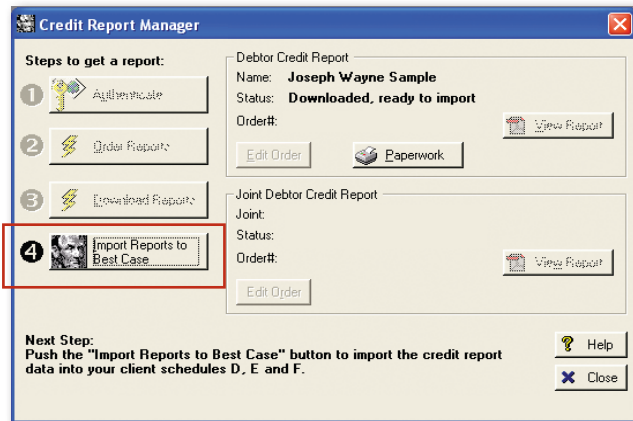
Select an individual or a joint report, then click **Next**. Choose **Order Reports Now** and answer a few quick questions to confirm the debtor's identity.

## 2 Download the credit report



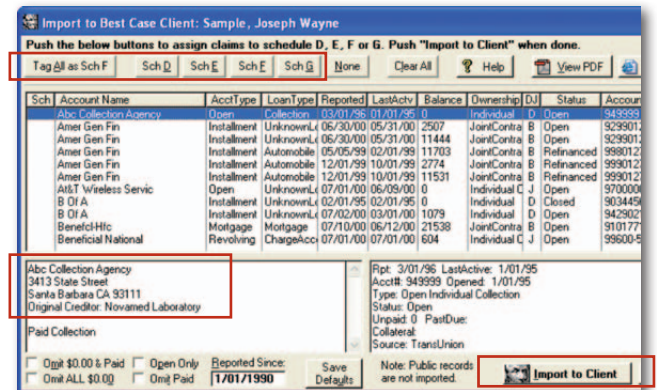
Click **Download Reports**. After downloading, view a PDF of the report by clicking **View Report**.

## 3 Import the report into Best Case

## 4 Assign to Schedules D, E, F, or G



Assign each claim to a Schedule with easy-to-use buttons. Enhanced flexibility allows you to choose to import the BSA and/or the CRA. Click **Import to Client** to complete the task.
