

Best Case® Bankruptcy Software
License Agreement Addendum - CyberlinkUSA

The undersigned is a current Licensee of the Best Case Bankruptcy Software products listed below ("Software") of Best Case, LLC, pursuant to the License Agreement (www.bestcase.com/licenseagreements.htm) that Licensee agreed to at the time that Licensee downloaded and installed the Software (the "License Agreement"). Licensee wishes to use the application hosting services of CyberlinkUSA, LLC ("Cyberlink") and to include the Software within those services. The Licensee wants, and Best Case is willing to provide, permission to include the Software within the application hosting services of Cyberlink notwithstanding any prohibitive terms of the License Agreement. In this regard, Licensee and Best Case agree as follows:

1. Permission. Notwithstanding any prohibitive term of the License Agreement, Licensee is permitted to provide Cyberlink with access to and use of the Software, in connection with its providing application hosting services to Licensee, including the right to make a copy of the Software to be retained on a server owned or controlled by Cyberlink and used for the benefit of Licensee. Access to and use of the Software by Cyberlink is solely for purposes of providing services to Licensee. Licensee will ensure that Cyberlink agrees that such access and use is restricted by the License Agreement, as modified by this Addendum. Cyberlink's breach of the License Agreement is a breach by Licensee.
2. Support and Fulfillment. As long as Licensee maintains the standard maintenance and support offered with the Software, Best Case will provide access to Cyberlink to such maintenance and support for use on behalf of Licensee. Licensee understands that if it fails to continue maintenance and support at any time after the initial term, that Best Case is under no obligation to provide such maintenance and support, including product releases and updates, to Cyberlink (or Licensee). Licensee authorizes Cyberlink to act as a fulfillment agent on Licensee's behalf.
3. Software. The following Best Case Software products are subject to the permission granted pursuant to this Addendum.
